

ORDINANCE 22-LL

AN ORDINANCE AMENDING CHAPTER 28, COMPREHENSIVE FEE ORDINANCE, OF THE CODE OF ORDINANCES, CITY OF ALVIN, TEXAS, FOR THE PURPOSE OF AMENDING PARKS AND RECREATION RENTAL FEES FOR THE USE OF THE ALVIN SENIOR CENTER AND ATHLETIC FACILITIES; PROVIDING FOR AN EFFECTIVE DATE; AND SETTING FORTH OTHER PROVISIONS RELATED THERETO.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ALVIN, TEXAS:

Section 1. That Section 28-2 of the Code of Ordinances, City of Alvin, Texas, is hereby amended by revising the Parks and Recreation rental fees as follows:

Sec. 28-2. In General.

...

PARKS AND RECREATION

(1) Athletic Facilities (non-association groups):

- Daytime use, per hour per field\$35.00
- Night use, per hour per field (lighted fields)\$60.00
- Security/cleanup deposit\$200.00
- Security supplied by city: Actual cost.

(2) Athletic Facilities (sports association):

- Lighting fees, per hour, per field with a one hour minimum\$35.00
- ~~Light scheduling: Fifty dollar (\$50.00) call-out fee in addition to the regular hourly fee for light usage requested after 10:00 a.m. on the day of the usage.~~
- Key deposit for key(s) to concession and storage buildings, per key\$50.00
- Damage deposit (if applicable) for restrooms and/or concession and storage buildings\$500.00
- Damage or misuse of restrooms during league use, [which] will be assessed to the sports association per incident per restroom~~\$50.00~~ actual cost

(4) Senior Citizen Center rental:

Clean-up/Damage deposit:

For use of either west or east side\$100.00

Entire building\$150.00

Rental fee(s) ~~w~~West ~~s~~Side Assembly Room with Kitchen (Occupancy 229):

- Per hour (3 hr. minimum) during ~~w~~orking-business hours (resident)~~\$70.00~~ 80.00
- Per hour (3 hr. minimum) during ~~w~~orking-business hours (non-resident)~~\$80.00~~ 90.00
- Per hour (3 hr. minimum) after ~~w~~orking-business hours (resident)~~\$80.00~~ 90.00
- Per hour (3 hr. minimum) after ~~w~~orking-business hours (non-resident)~~\$90.00~~ 100.00

Rental fee(s) ~~(e~~East ~~s~~Side): Assembly Room with Kitchen (Occupancy 80)

- Per hour (3 hr. minimum) during ~~w~~orking-business hours (resident)~~\$50.00~~ 60.00
- Per hour (3 hr. minimum) during ~~w~~orking-business hours (non-resident)~~\$60.00~~ 70.00
- Per hour (3 hr. minimum) after ~~w~~orking-business hours (resident)~~\$60.00~~ 70.00
- Per hour (3 hr. minimum) after ~~w~~orking-business hours (non-resident)~~\$70.00~~ 80.00

Rental fee(s) ~~(both sides):~~ East and West Side Assembly Rooms (Occupancy 309)

- Per hour (3 hr. minimum) during ~~w~~orking-business hours (resident)~~\$90.00~~ 100.00
- Per hour (3 hr. minimum) during ~~w~~orking-business hours (non-resident)~~\$95.00~~ 105.00
- Per hour (3 hr. minimum) after ~~w~~orking-business hours (resident)~~\$100.00~~ 110.00
- Per hour (3 hr. minimum) after ~~w~~orking-business hours (non-resident)~~\$105.00~~ 115.00

Rental of the Craft Room or Board Room (Occupancy 25) (Rooms are available only for rental by adult organizations Mon.-Fri.):

- Per hour (3 hr. minimum) (resident/resident group)~~\$35.00~~ 45.00
- Per hour (3 hr. minimum) (non-resident/non-resident group)~~\$45.00~~ 55.00

Rental for Non-Profit Organization (Note to file, changes were not codified in 2019 - Ord 19-BB)

- Deposit is waived
- Per hour (3 hr. minimum) (resident/resident group)\$55.00

Rental of Audio / Visual Equipment (1x Charge) \$50.00 (Note to file, changes were not codified in 2019 - Ord 19-BB)

Refund processing fee\$25.00

Cancellation fee within two (2) weeks of reservation-rental date\$75.00

Section 2. That except as amended herein all other provisions of Chapter 28 of the Code of Ordinances, City of Alvin, Texas, shall remain in full force and effect. To the extent of any conflict or inconsistency between the provisions of this ordinance and any other ordinance, the provisions of this ordinance shall control.

Section 3. Severability. Should any section or part of this Ordinance be held unconstitutional, illegal, invalid, or the application to any person or circumstance for any reasons thereof ineffective or inapplicable, such unconstitutionality, illegality, invalidity, or ineffectiveness of such section or part shall in no way affect, impair or invalidate the remaining portion or portions thereof; but as to such remaining portion or portions, the same shall be and

remain in full force and effect and to this end the provisions of this ordinance are declared to be severable.

Section 4. Effective Date. This Ordinance shall take effect immediately after its passage and publication in accordance with the provisions of Chapter 52 of the Texas Local Government Code the City of Alvin Charter.

Section 5. Open Meetings. It is hereby officially found and determined that the meeting at which this Ordinance is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551 of the Texas Government Code.
