

RESOLUTION 20-R-07

A RESOLUTION BY THE CITY COUNCIL OF THE CITY OF ALVIN, TEXAS, CANCELING THE ESTABLISHED PROCEDURES FOR THE MAY 2, 2020 GENERAL ELECTION IN ALVIN, TEXAS; AS THE POSITION FOR MAYOR AND CITY COUNCIL MEMBER DISTRICT E ARE CERTIFIED AS UNOPPOSED; AND PROVIDING FOR OTHER RELATED MATTERS RELATED THERETO

WHEREAS, on February 6, 2020, City Council called for a General Election to be held on May 2, 2020, by adoption of Resolution 20-R-03, to elect the following officials for this City: a member to the position of Mayor and City Council District E; for a term of three (3) years; and

WHEREAS, as the following candidates have been certified as unopposed and are hereby elected as follows, the General Election scheduled to be held on May 2, 2020, in accordance with Section 2.053(a) of the Texas Election Code should be canceled:

NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF ALVIN, TEXAS:

Section 1. General Election Ordered. The General Election of the City ordered for Saturday, May 2, 2020, to elect members to the position of Mayor and City Council District E; for a term of three (3) years is hereby canceled. The ballot shall list the candidates and position with the wording: Unopposed Candidates Declared Elected.

Section 2. Special Election Ordered. The Special Election ordered by Resolution 20-R-04 will still be held and conducted by the Brazoria County Election Officer in compliance with the *Texas Election Code* and the Election Agreement.

Section 3. Attachments. Attachment A is the Official Certification of Unopposed Candidates Form as prescribed by the Texas Secretary of State. Attachment B is the Official Order of Cancellation Form as prescribed by the Texas Secretary of State. A copy of such order (Attachment B) will be posted on Election Day at each polling place that would have been used for the General Election.

Section 4. Open Meetings Act. It is hereby officially found and determined that this meeting was open to the public, and public notice of the time, place and purpose of said meeting was given, all as required by the Open Meetings Act, Chapter 551 of the Texas Government Code.

Section 5. Effective Date. This Resolution shall be in force and effect from and after its passage on the date shown below.
